BCIS DIGITAL CITIZENSHIP:

RESPONSIBLE USE OF TECHNOLOGY AGREEMENT

The BCIS community seeks to create a safe and secure learning environment by following the 4 BE's - Be Safe, Be Respectful, Be Responsible and Be Compassionate, respecting the principles of Digital Citizenship and following the Responsible Use of Technology guidelines outlined below.

Internet Safety, Privacy & Security

- use only assigned accounts and networks to which students are authorized access
- manage personal online information and keep it secure from online risks
- set up devices with a trusted adult to ensure strong passwords and age- appropriate privacy settings
- respect the privacy of self and others by requesting consent before posting any images or online information
- understand the concept of a permanent digital footprint
- communicate with a trusted adult- parent and/or teacher should there be breaches to online safety and security
- devices should be stored properly when not in use and should not be left unsupervised and/or in a public space

Well-being: Self-Image, Identity, Relationships & Communication

- stay balanced by being mindful of daily screen time
- communicate with respect, kindness and compassion to others in all digital communications
- ensure all online communications and use of learning platforms (ZOOM, Seesaw, Teams) are appropriate at all times, and you show a true representation of yourself. (Please see associated BCIS Online Learning guidelines)
- monitor my use of media and the connection to my well-being, seek support if needed
- communicate and/or report unsafe or harmful online communications to a trusted adult

Technology Care, Responsibility & The Learning Connections

- take care and be responsible for all personal learning devices and seek permission before using others' devices
- ensure devices are used as directed for learning purposes, and not a source of distraction to self and others
- report to the IT Department and parents should a device be broken or lost

Mobile Phone Use

- ECC phones are to be kept in school bags
- Grade 1-5 phones are to be kept in school bags
- Grade 6-8 phones are permitted in classrooms when requested for specific learning experiences (Phones should otherwise be placed in the student's locker/school bag)
- Grade 9-12 phones may be used to support learning unless otherwise directed by teacher

Information Literacy: Creative Credit and Copyright

- understand their responsibilities and rights as creators in online spaces
- evaluate the quality, credibility, and validity of online sources.
- respect copyright and acknowledge the work of others, through citing our work (i.e. MLA referencing).

Consequences for Inappropriate Use of Learning Technologies

Understanding the importance of responsible technology use and digital citizenship is clearly communicated in the above guidelines. Inappropriate use of learning technologies will be determined according to seriousness of the violation and an investigative process. Consequences may include restorative conversations and conflict resolution, limited access to digital devices and the school network, suspension and/ or in extreme cases expulsion as guided by other relevant policies and procedures.

Supervision and Monitoring

BCIS, school network administrators and their authorized employees monitor the use of learning technologies to help ensure that use is secure and in conformity with this policy. BCIS cannot guarantee nor be held responsible for the accuracy or appropriateness of online resources. Administrators reserve the right to examine, use, and disclose any data found on BCIS information networks in order to further the health, safety, discipline or security of any community member or other person, or to protect property. They may also use this information in disciplinary actions and may be required to furnish evidence of crime to law enforcement officials.
